PARENTAL/GUARDIAN PERMISSION AND WAIVER

REGISTRATION FEE: \$250 If payment is received before 8/1/2010. \$275 if payment is received on or after 8/1/2010 or if on a installment plan. Family plan: 1st participant is \$250 (or \$275 on or after 8/1/2010) each additional sibling is \$175.

INSTALLMENT PLAN: \$125 before 8/1/2010, additional \$75 by Certification Day and \$75 by 9/15/2010. If full payment is not received by 9/15/2010, participant will be removed from team until full payment is received.

FINANCIAL RESPONSIBILITY: I agree to pay all participant fees as specified by the Daly City Titans in a timely manner. **There will be no refunds.** I have also been advised of my fundraising obligations for the entire season and agree to fully comply with those obligations.

RETURNED CHECKS: There will be a processing fee of \$25 for returned checks.

EQUIPMENT RESPONSIBILITY: I agree to assume full responsibility for any and all equipment/uniforms loaned to the above named participant and I agree to promptly return, upon request, the uniform and other equipment issued to the above named participant in as good condition as when received except for normal wear and tear. If I fail to adhere to this policy, I will be responsible for the replacement cost of such equipment; I will also forfeit my Equipment Deposit of \$100.

PHOTOS: I hereby grant my permission for the Daly City Titans to use photos of my child on the website and/or for other advertising purposes. Photos in hand will be the property of the Daly City Titans. If you do not wish to participate, you can opt out by notifying the Daly City Titans in writing.

ADULT CODE OF CONDUCT: In order to uphold the goals of the Daly City Titans and ensure that all participants have the benefit of a safe and fun learning environment, all parents, guardians and other adults and attendees of any and all Daly City Titan events, including but not limited to practices, competitions, and banquets, must behave accordingly in a respectful, courteous and sportsmanlike manner at all times.

Any adult who is using alcohol, tobacco or non-prescription drugs and/or appears intoxicated at a Daly City Titan event, and/or who is flagrantly rude, attempts to intimidate, verbally abuse, heckles, taunts, ridicules, boos, throws objects and/or uses vulgarity or profane language/gestures with an official, coach, volunteer, staff, member, participant or other event attendee, must receive a verbal warning and/or be asked to leave Daly City Titan event. The member organization may also provide a written warning to the individual regarding the misbehavior. The adult's child(ren) may also be removed from the event. Any adult, who commits one of the above stated offenses a second time, will be banned from any and all Daly City Titan events for a period of one year from the date of the second offense, and their child(ren) may also be removed for the program(s) for that time period.

Any adult who physically assaults an official, coach, volunteer, staff member or participant or threatens grave bodily harm may be banned from any and all Daly City Titan events for one year from the date of the offense, and their child(ren) may also be removed from any and all Daly City Titan programs for that same period of time. After the ban has expired, if the individual commits another offense of the Adult Code of Conduct, the individual will be permanently banned from any and all Daly City Titan events and the individual's child(ren) may also be permanently removed from any and all Daly City Titan programs.

RULES AND REGULATIONS: I hereby understand and acknowledge that as a parent/guardian of a Daly City Titan participant, it is my responsibility to comply with all rules and regulations stipulated, adopted or recognized by Daly City Titans, including but not limited to the Adult Code of Conduct. Any non-compliance with any and all rules and regulations may be cause for discipline and/or dismissal of my child/participant, myself, and/or any spectators or other persons affiliated with the undersigned and the above named participant.
